- 1. Minutes from the October 10th, 2024 Township Board meeting were viewed, approved, and signed by the Board.
- 2. The Proof of Budget Submission for 2025 was reviewed by the Board.
- 3. The 1782 Notice showing approval of the 2025 Budget with no cuts was reviewed.
- 4. The December 2024 Settlement from Vanderburgh County was reviewed by the Board.
- 5. The MVFD Mileage Report for the third quarter of 2024 was reviewed.
- 6. The amended Fire Protection Contract for 2024 submitted by Chief Elliot was reviewed by the Board. The Deputy Trustee will hold the Amendment for Board Signatures.
